St Philips Parish, 21 May 1710, RB6/37, p. 273

Land I bought of Mulineux; the chn of son Robert Gittens all at 13; son John Gittens the elder if ever he shall come in person to demand the same; my son Isaac Gittens; gr son Matthew Chapman the son of dau Sarah Gittens now Sarah Chapman, all her chn at 14; son John Gittens the younger to be maintained and educated to age 21; the chn of Peter Wilkinson; my dau Rebecca Gittens at 17; son Joseph Gittens - Xtr. signed Isaac Gittens  
Wit: Charles Irvine, Thos: Gibbs, John Jackman, Richard Catford Cod, 28 Mar 1713, Son Joseph is now in foreign parts, my wf to be Xtrx until his arrival; son Joseph's said mo his Gdn; my wf - Gdn to my son John if Joseph does not come back; my gr son Isaac Gittens; eldest son Robert Gittens - all the iron and coal now in the house in full of all demands.

A house in St Michaels Town joining the house where John Lenaire lives; sons Isaac Gittens and John Gittens - 200 lbs. left me by my fa Isaac Gittens decd; my wf Ann Gittens - Xtrx and Gdn; bro Joseph Gittens - Asst Xtr. signed Isaac Gittens

St Philips Parish, 17 Oct 1714, RB6/35, p. 466

My dau Elizabeth Gittens - negro girl Mary Drake; my son Edward Gittens at 21; son Nathaniel Gittens at 21; dau Rebecca Gittens at 18; dau Hannah Gittens at 18; kinswomen Eliza Ashly and Mary Ashly; mo Hannah Gittens widow; land given me by my decd fa John Gittens in his will; wf Hannah Gittens, and son Samuel Gittens under 18 - Xtrs; bro Samuel Gittens and friends Geo: Bushell and Ralph Weeks - Gdns. signed Joshua Gittens

St Philips Parish, 2 July 1715, RB6/4, p. 38

Son Isaac Gittens when he shall be free from apprenticeship; son Robert Gittens\* the younger; dau Eliza: Gittens at 15; dau Sarah Gittens at 15 - money due me in partnership with Tho: Hodgkins, Capt. Roger Webb, and others; my bro Joseph Gittens and my wf - Xtrs. signed Robr: Gittens

Wit: John Hearer, Joseph Gittens, and Christian (x) Kesley (or Lesley)

Proved 11 Oct 1716
